
- **Jurisdiction** : The society shall work with all over Haryana.

RULES AND REGULATIONS OF WESLEY EDUCATIONAL SOCIETY

- **Name of the Society:** "WESLEY EDUCATIONAL SOCIETY"
- **Membership of Society:** The membership of the society shall be voluntary and open to all members those who are interested in or are engaged in rural development.
- **Re-admission of expelled/suspended members:** In terms of the provisions contained in section 22 of the Act, or suspension and reinstatement of a member. If deemed necessary or who has been removed from membership on the direction of the District Registrar/Registrar/Registrar General for any misconduct should be re-admitted.
- **Members Rights/Privileges and duties:** Every member shall enjoy all rights and privileges assured by the constitution of the society and the rules framed hereafter provided he has not paid any kind of arrears on his behalf.
- **Definition of General body:** All members enrolled as a member under clause 2 above shall form a general body of the Society.
- **Size of Governing body and the Collegium:** The governing body shall consist of not less than seven members and not more than fifteen members including the office bearers.
- **Election of the Collegiums/Governing Body:** The affairs of the Society shall be managed by the Governing body to be elected by the secret ballot in the month of August of every year.
- **Term of Governing body:**
- **Requirement of Notice of meeting of the Governing Body:** The general secretary shall give notice at least 5 days notice for any extra ordinary general body meeting.
- **Quorum of Meeting:** Quorum of the general body meeting will be 51% of the total members and the decision shall be taken by the majority vote. If within half an hour of the time fixed for the meeting, the quorum is not present, the meeting shall stand adjourned for the same day, place and time in next week and on which date the members present shall form the quorum.
- **Governing Body and urgent Meetings:** The governing body shall meet at least once in a month for which a notice of at least 5 days shall be given by the General Secretary. Any urgent meeting can be called on a notice of 24 hours with the approval of the president.


51% of the total members shall form the quorum of the meeting. In the absence of the quorum the meeting shall stand adjourned and meet again as determined by the members present. This shall be circulated by the General Secretary of the society to all the members.

- **Powers of Governing Body:** The governing body shall meet at least once in a month to meet to transact the following business:
 - To prepare plans and policies for the smooth management of the society.
 - To sanction the expenditure for the society.
 - To arrange finance if required from other institutions banks or individual on reasonable terms and conditions and the Governing body as a whole shall be liable for its return.
 - To appoint any staff for the society and to fix its duties and responsibilities.
- **Office Bearer of Society and their Powers (President):** The governing body shall work under the supervision and control of the president who shall invariably preside over all the meetings of the governing body and the general body.
- **General Secretary/Secretary:** The general secretary shall be responsible for convening all the meetings, maintenance of minutes, correspondence, membership register and all matter assigned to him by the Governing body.
- **Management of funds by Treasurer:** The cashier shall be responsible for collection of subscription, maintenance of records and accounts of receipts and disbursement., Bank account, safe custody of the funds of the society and pay the bills and expenses after getting the approval of the president, general secretary and present monthly accounts before the Governing body. He will keep Rs.500 with him and the balance amount will have to be deposited in the bank.
- **Sources of Income of a Society:** Funds of the Society shall consist of grants, aid subscription, donation etc. and shall be utilized towards and promotion of the aims and object of the Society.
- **Provisions relating to Audit of the Society's Accounts:** The accounts of the Society shall be audited at least once a year by and auditor appointed by the General Body.
- **Operation of Bank Accounts:** Bank accounts of the Society shall be operated by ANY TWO office bearers from President, General Secretary and Treasurer. The society have a right to take loan from bank regarding any kind of purchasing asset or construct building etc.

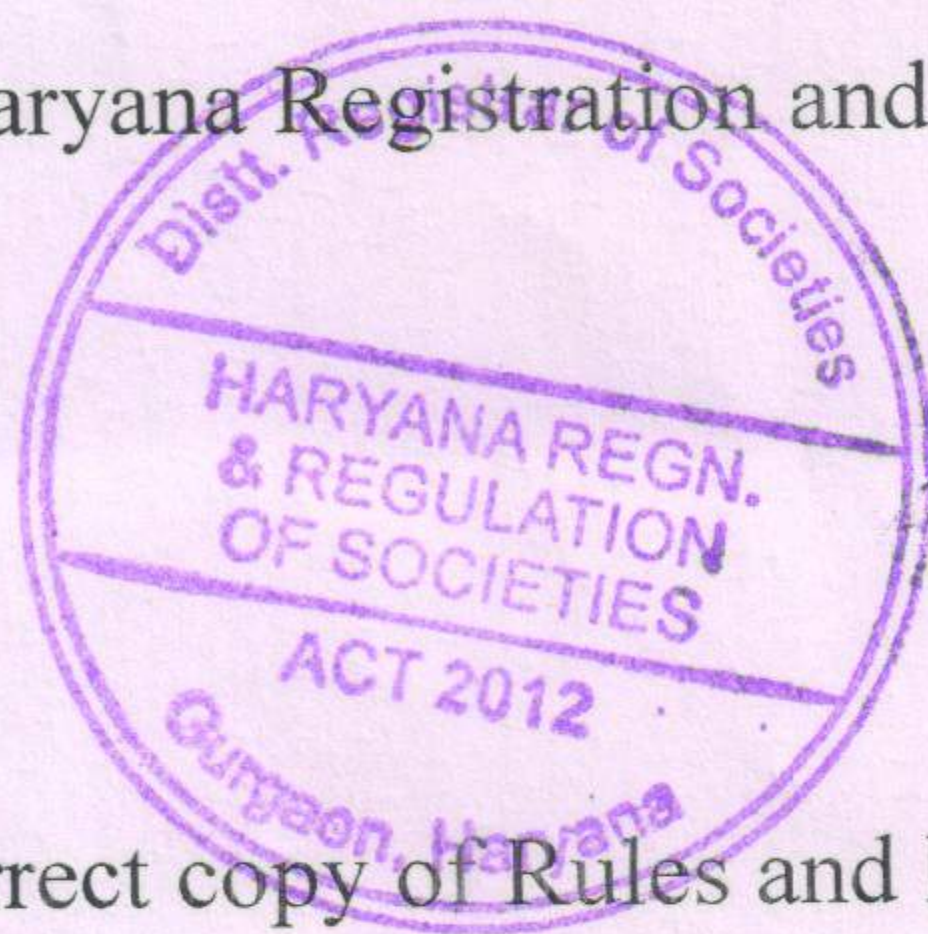
